



Layoffs, economic cutbacks, and the foreclosure trends have led to a devastating number of families who just cannot make ends meet. Recently, the *Indianapolis Star* reported a 78 percent increase in family homelessness since early 2008 in Marion County.

CHIP'S HOMELESS COUNT REVEALS INCREASED NEED

In their annual homeless count, the Coalition for Homelessness Intervention and Prevention (CHIP) found a 78 percent increase in family homelessness in the last year. In addition, the number of individuals counted on the street rose by 40 percent. CHIP counts only Marion County individuals who are sheltered or unsheltered as part of their count, meaning that families or individuals who are living with friends or relatives have not been counted.

At this year's Annual Meeting, attendees and members of a panel noticed a particular challenge to the service provider community this year: to continue to support the homeless who come from addiction, mental illness and domestic violence as they always have while also serving the 'newly' homeless who have been affected by economic conditions. Certainly a variety of resources are needed to address the new tier of individuals or families who need assistance.
